## State Match Payment Deposited December 8

Districts received a payment for "State Match" on December 8. This is for the School Nutrition Program (SNP) reimbursement payment and should be deposited to the Food Service Fund (Code 24) as revenue code 3203 School Food Assistance.

#### Deposit Special Education in General fund and transfer

**Special Education state aid** will direct deposit on Friday, December 15. As you will recall, the law requires all special education state aid payments to be deposited in the school district's general fund budget (Code 06, Line 120 – 3205 Special Education Aid). The revenue would then be transferred from the general fund to the special education fund (Code 30, Line 75 – 5206 Transfer from General).

Detail reports are posted online. To view payment amounts and print the special education detail reports, link <a href="here">here</a>. Select FY24 Special Education State Aid Printout. If a security warning appears in a yellow bar above the spreadsheet, click on Enable Content to proceed.

Next, with your cursor, locate Cell F3 (in red) and click on the arrow to scroll up and select your LEA number. The information will refresh when the LEA number is updated. To display each report, select a tab located at the bottom of the screen (Special Ed, Coop Split, Payment Received).

### Legal Max Letter Information

Two copies of the "preliminary" legal max letter dated December 11 were mailed to the Superintendent (cc: Board Clerk). A third copy was mailed directly to all board presidents. Please note the following:

- 1. The Adjusted Enrollment is based on the higher of the 1<sup>st</sup> preceding year or 2<sup>nd</sup> preceding year's enrollment, or 3-year average if:
  - a) your district receives federal Impact Aid and
  - b) your district has military dependent students and
  - c) declined in enrollment.
- 2. The WTD FTE (enrollment weightings) are calculated based upon the Superintendent's Organization Report (S066) unaudited enrollment as filed by your district in October.
- 3. The Budget Reductions are reflecting the cap where current year transportation state aid (based on students transported 2.5 miles or more) cannot exceed 110 percent of the prior year's transportation costs for <u>regular</u> route. Please reference the "Transportation" worksheet tab. Also, as KSDE audits are processed and CPA annual audit reports are reviewed, this may also include adjustments for overpayment of prior year Virtual Credits or budget reductions due to overspending the general fund.
- 4. Required transfers from General Fund and LOB can be reviewed on the "Required Transfers" worksheet tab.
- 5. The Legal Max General fund and Legal Max Supplemental General fund are the lesser of the computed budget or adopted budget.
