If a resolution wasn’t adopted during the 45-day period, the district could proceed with the disposition of the building. If a resolution was adopted, the state agency named in the resolution would have 180 days to complete acquisition of the building. Receiving states are required to grant equivalent licenses to active military members and their spouses, so long as their license at the time of transfer is not otherwise encumbered. Receiving states are not required to grant equivalent licenses to a career and technical education teacher who does not meet the receiving state's industry recognized standards. Compact becomes effective when Compact statute is adopted in the 10 th member state.

Credits can be claimed for up to three successive calendar years after the probationary period ends. The tax credit amount is subject to a scale developed by the Department of Revenue and may be up to \$2,500 per apprentice, not to exceed 20 apprentices per year. The credit cannot be awarded for employment of the same apprentice more than 4 times.
	Statute Book	Program Evaluation (beginning in 2025)	6-7	Educator Registered Apprenticeship Grant Program	Creates the Kansas Educator Registered Apprenticeship Program and directs the State Board of Education, Commissioner of Education, and Secretary of Commerce to develop and administer the program. The program awards grants to education apprentices attending applicant schools to increase the number of qualified, credentialed teachers in Kansas. Requires rules and regulations to be adopted by March 1, 2024 including detail on the grant application process, terms and conditions of the grant, and method to award grants. The program must be evaluated annually by the Commissioner of Education and State Board beginning in 2025. The report of such evaluation is to be submitted to the House and Senate Committees on education and commerce by January 31 of each succeeding year.
