Only 3 days remain to submit. Form 308 data is used to calculate the FINAL Special Education state aid payment depositing June 1. As of today, our records indicate that 65 districts, interlocals and special education cooperatives have not started the Form 308 needed to calculate the June 1 special education state aid payment. We have received 139 completed reports, and 100 reports are in progress.

Announcing the 2023 EPA Clean School Bus Grant Program!

EPA anticipates awarding approximately \$400 million in competitive grant funding under the Clean School Bus (CSB) Grants Program Notice of Funding Opportunity (NOFO). The program is soliciting applications nationwide for a grant competition to fund the replacement of existing school buses with clean and zero-emission (ZE) school buses. Please note this is a grant opportunity and not a rebate.

All application packages need to be submitted electronically to EPA through Grants.gov no later than Tuesday, August 22, 2023, at 11:59 p.m. (ET) to be considered for funding.

Potential applicants without a <u>Grants.gov</u> account are encouraged to initiate the <u>Grants.gov</u> registration process well ahead of the deadline for funding since the registration process can take a month or more.
