**ESI** Reporting:

- Initially include special education directors so they can help guide principals to get ESI quarterly reports completed.
- Directors want to review the data by building. When revised we could suggest having a by district report.
- Give directors a prior email so they can alert the appropriate staff that the reporting will be coming.
- We have also been to several conferences across the state sponsored by multiple agencies.
- Jana and Laura will be going to Greenbush to speak to superintendents tomorrow.
- Superintendents are encouraged to call and discuss concerns.

The Law Enforcement Center is concerned about having an exception on using mechanical restraint when following arrest procedures. If they use their police training, they are not following regulations. This puts them in a position of being liable. Attorneys from our department and law enforcement are working through the situation.

The SEAC will have the opportunity to review any changes made to this regulation over time.

A letter was sent to the executive director of the Kansas Association Of School Boards pointing out where training they are providing is incorrect and does not include specific elements of the regulations. We have not had a response as of today's SEAC meeting.

The State Board asked for KSDE to do a presentation at the KASB conference.

KASB did send a representative to the Tri-State Law Conference.

TASN – numerous presentations have been occurring. Request for Proposal (RFP) process will be available soon for TASN providers. Timeline has changed due to departmental timelines changing. Recommendations will be made to the KSDE leadership team and then brought to you in January. If you know of providers that would be interested please share with them our RFP partnerships or let Colleen know how she can contact them.

Elementary and Secondary Education Act (ESEA) Flexibility Waiver has changed the work of our department. We are implementing the steps in the waiver. It is different than Adequate Yearly Progress (AYP). There are a lot of requirements that came with the waiver. Kansas was placed on high risk status this summer due to the work on teacher evaluation not being in a completed form. The Commissioner has responded and requested that the high risk status be removed. We have not yet had a response from the Department of Education on that question. The evaluation of teachers is the main difficulty. Conversations continue between departments and across the state.

SEAC Breakfast with the State Board – Invitation is in your packet. Full day SEAC meeting on Tuesday, Breakfast on Wednesday and ½ day SEAC meeting on Wednesday. This is our opportunity to speak to the state board on the issues we are addressing and the state board can ask questions of you. These have been very beneficial to our work and that of the State Board in the past. We will also be introduced at the state board meeting on Tuesday – Bryan and Penny will present SEAC members and annual report from 2012-2013.

Lexia5 has contacted KSDE and is working with school districts to create supports. We will be collaborating on the work for the Priority and Focus schools.

Governor program – Kansas Reading Roadmap Initiative. Governor's team is working with the Department of Children and Families (DCF), Save the Children, Rural Trust and Families and Schools Together. Anything you can do in regard to communicating with legislators about the appropriations for special education funding would be appreciated. Current level is the same as 2008-09. Base state aide in 2008-2009 was \$4800 and is now down to \$3838. As a result, the state is asking more of the local districts to meet the federal laws.

Kansas teacher salaries are now 42<sup>nd</sup> in the nation. Academically our kids remain in the top 10 in the nation.

- Topeka has 10 fulltime positions.
- One officer works with Topeka PD on truancy issues
- Police officers are required to go through a 4 or 6 month training to be certified.
- Officers always receive training on dealing with conflict. First objective is to resolve the altercation peacefully.
- Crisis intervention and verbal judo are included in officer training.
- Officers work to de-escalate the situations.

# Update from State Board Meeting – Colleen

- State Board has been having a discussion on Individual Plans of Study (IPOS) this morning. This directly connects to our discussion earlier this morning on student outcomes.
- KSBE strongly recommends individual plans of study for all students' grades 8-12.

#### ESI Update – Jana and Laura

• Regularly respond to parents, schools, and KAN-DIS questions in this area.

Letter to Dr. John Heim at KASB about the training they were providing and its inaccuracy in a few aspects asked them to clarify their trainings. Response was received and policy has been updated and released with other policies in December. If your local board has adopted the original version of the policies they need to be aware of the update and adopt the new version.

Visits to several schools have been conducted following invitations to come see the programs that have been put in place.

Lakemary and Heartspring follow-up -

- We have provided supports through our TASN network to help them come into compliance with the regulations.
- Lakemary is undergoing major construction. They are currently housed in a former convent. It took away their ability to use seclusion because they no longer have access to a specified room for that purpose.
- Work continues with these schools on the de-escalation of events and inclusion of PBIS into their structure.
- Heartspring visit on Jan. 9. A walkthrough of classrooms was completed first. An abbreviated presentation was done with their staff. They are working to identify alternate means of restraint, determine when they are needed, and increase the use of de-escalation strategies.

# Questions:

As districts consider making recommendations for placements, we must consider the institutions compliance with regulations. With the implementation of any regulation, comes a realization that change does take time. Your involvement with these entities is critical. Access to meaningful and engaging curriculum as well as a safe environment where challenging behaviors will be de-escalated and eventually reduced in occurrence is critical.

# Early Childhood and ESI

There is concern that the ESI regulations were in conflict with childcare licensing regulations. The licensing regulations do not allow for the use of seclusion and restraint. We do not feel that they are in conflict. If seclusion and restraint are not allowed, there is no need for training on the use of them but there is need for training in de-escalation strategies and positive behavior supports. Training will be provided at the KDEC meeting in Wichita for Early Childhood. Look at the TASN website for more information or contact Dave Lindeman or Vera at KSDE.

When we receive parent concerns, we direct them to the districts website for the policy and also contact the school and appropriate staff to assist in resolving the parents' concerns.

  - Much anxiety exists around this issue. Our KSDE staff made a commitment that Kansas would not define the word significant with a percentage. Must use multiple measures to show growth only one of which is the state assessment, one must be a common assessment (purchased assessments), and locally developed assessment. This is only one side of the evaluation tool. The other side is about the profession of teaching. Creating a total of 7 categories to be considered. It will be the local district that determines what significant means in their district.

#### Secondary Transition Services Discussion Community Based Instruction (CBI) (Link to Handout)

Bryan Wilson

This handout is currently used by Wichita. It was created by using resources from many districts across the nation. We are making sure students receive the interventions necessary as well as the prevention services they need is a challenge.

- Community based instruction is very important and will stay alive if administration supports it. It is progressing in our district with use of time and funds for CBI programs. Very important to the development of skills needed for students.
- Structural level is needed to achieve the outcomes of IDEA. Can universities be partners or resources?
- Kansas College and Career Ready Standards (KCCRS) focuses on the career piece. Like the components in this document that outline the soft skills. CTE pathways may be an additional resource.
- TASN may be able to assist in curriculum modification.
- List of expectations and resources on the last page of the handout.

This would be a good topic for continued discussion at meetings throughout the next year as it a part of our State Performance Plan. Retired university professor groups might be a resource to tap into for additional involvement.

Getting kids into the community businesses is also a key to developing relationships for business partnerships. Include parents in the development of programs for their students in the community.

# Kansas Educator Evaluation Protocol (KEEP)

Bill Bagshaw – Assistant Director Teacher Education and Licensure, KSDE

Website for KEEP: Link to KEEP website

This is an educator evaluation system that builds a quality standard for both the teacher and the administrator. KEEP is available to all schools at no cost but is not required. An evaluation tool with specified components is required but it does not have to be KEEP.

Three areas are looked at in the KEEP system, student growth, instructional practices, and summative performance rating.

Instructional practice pieces are developed and measured locally.

Student growth is measured in multiple ways. One of which is the state assessment. It is now looked at over a 4 year period and not just a single year. The other two measurements are a vendor assessment and a locally developed assessment.

Suggestions of possible growth measures that districts are using are available under the Student Growth Measures tab on the webpage.

Schools/districts determine their own guidelines.

#### Teacher Licensure Update – Susan Helbert

Regulation changes are moving forward to provide the framework to set up Special Education as a direct entry license. Special Education Elementary Unified License is similar to the Early Childhood unified license.

Generalist High Incidence is the other new area and will allow for content endorsements to be added.

In May, the new regulations will go to the State Board as an action item.

#### Questions

Is it possible for the student working on the generalist high incidence license to take more courses for areas and not have to take the Praxis? It will still require a Praxis test as it is required for all new licenses in content areas.

Will the Elementary Unified be high and low incidence combined? The idea is for this to apply to high incidence. Low incidence has not yet been addressed in this process. A student cannot enter a special education endorsement by testing only.

An online application has been opened for provisional licenses. This is new and is still in process. We are working with higher education to get the information to their students.

#### Assessment Update: Deb Matthews, KSDE

All state assessments are new this year.

Dynamic Learning Maps (DLM) – for significantly cognitive disabled students - The DLM process was bumpy in the beginning but has smoothed out.

Kansas Interactive Testing Engine (KITE) system has had issues with outside attacks that required some additional work.

Approximately 50% of students have now been tested as of today. (April 15)

We are using this year's assessment as a learning tool. It was never intended to be more than a transitional assessment between our old state assessment and the new assessment which will be ready for next year.

We are learning about the potential of what students can do and be asked to do in the testing environment. We are very concerned about the quality of results due to the system attacks. Brad Neuenswander, Deputy Commissioner, is in conversation with the US Dept. of ED about how to proceed with accountability.

#### Handout -

These are examples of DLM messages that have been sent out to help instructors meet the challenges of the new system(s). Modules to help in specific areas have and continue to be developed.

The Summer Leadership Conference will include information on the assessment and also the adaptability that will be available next year including braille usage.

**Juvenile Corrections** – Penny Lawson will be sending an email which will be shared with the council when it is received about the re-organization of youth corrections.

Bryan received a request about Managed Care Organization (MCO) representatives being a part of IEP meetings. This is not a requirement. From the healthcare perspective, they want fewer services to be provided by the schools. This would allow the MCO to not offer them in the community centers. Inclusion of MCO's would be restrictive to the LEA not helpful to them.

#### KSDE Update -Colleen Riley-Handouts

- Summer Leadership Conference will be held in Wichita on July 23 with our SEAC meeting beginning at Noon with a working lunch at the Hyatt Regency. A two day conference follows the SEAC meeting. Pat will register SEAC members for the conference so please notify her of your needs.
- Deb Young has come home from the hospital and is making great progress. Voting for Deb is available through May 9<sup>th</sup> to help her receive a handicapped accessible van.
- State Assessment emails about the good faith effort to test all students.
- Commissioner DeBacker's resignation and appointment of Brad Neuenswander to serve as the interim commissioner. Commissioner DeBacker will be an advisor to the Director General of the Abu Dhabi Education Council.
- Kansas Annual Conference Call for Proposals is now open. Please consider making a proposal to spread the word on the good works you are involved in across the state.
- Rose Standards Draft document shows comparisons with the KCCRS, 21<sup>st</sup> Century Accreditation, and MTSS alignment. Brad is responsible for the development of this document if you have any feedback please send it to Colleen who will share it with Brad.

#### ESI Update – Jana Rosborough and Laura Jurgensen

New proposal for part 3 of the regulations is under development. Some proposed wording on law enforcement's use on prone restraints has been prepared. (Handout) Ron Brown was here at the last meeting to share information on the law enforcement perspective.

Cheryl Whelan, KSDE general counsel, has been working on a draft for section 3. 91-42-3 Handout – this is a draft, not a final document.

Using these definitions districts should be able to figure out who is exempt and who is not.

• SEAC is responsible for gathering information, having discussion, and making recommendations for moving forward. The SEAC chair would then move recommendations to the STATE Board who will then consider action. If they take action, it will then move forward to the next steps of approval for a regulation to be put in place. The process will take several months to complete.

Belief was stated that we need to keep moving forward to provide clarity.

When law enforcement use prone restraint, 99% of the time this will involve an arrest, at that point parents would be notified, so it will not change the intent of the ESI regulations for notification of parents or cause a gap in reporting.

Any school member involvement must be reported. If law enforcement becomes involved the other provisions in the regulations will have been covered.

We do receive calls about proper documentation and reporting frequently.

What does SEAC want from KSDE?

• Information on what KAN-DIS reporting covers.

We have options available to us to take action on this via conference call or at the next meeting.

Vicki proposes we schedule a conference call where this document is reviewed and a vote with a quorum is taken. Bryan and Colleen will work on scheduling a conference call to discuss action on the role of law enforcement in use of physical restraint. Notice of call information and draft language for 91-42-3 will be sent out soon.

Update on Heartspring and LakeMary. Yellow packet contains communication that has occurred since the last SEAC meeting.

Following KSDE's communication to districts, Lake Mary informed us that they had ceased using prone and supine restraints. We followed up this notification with a meeting to discuss the supports they needed to implement these changes. It does still occur on rare occasion. We have asked them to not only notify the parents but also the students' home district. They were very receptive to that recommendation. We continue to work with this school. We have also asked them to put in writing the policy that requires them to notify the sending district.

Members requested these communications to the districts should be sent to the Special Education Directors.

Both schools have requested a KLN needs assessment visit. We are looking forward to scheduling these visits. This came from a discussion with the schools about what can we do to support them.

Heartspring scheduled a meeting as follow-up to a meeting where they came in to talk with the commissioner, deputy commissioner, and Colleen. They are making steps toward full

implementation of the regulations by September, 2014. We will continue to work with them to reach implementation.

These two specialty schools are working to change the culture that currently exists. They are relying heavily on our TASN team. We are helping them tap into additional resources. The Disability Rights Center (DRC) is also involved in supporting the work.

We informed Kansas Directors of Special Education and also went a step further to notify Directors of Special Education of each state of the regulations in Kansas.

Indicator 13 – Post secondary transition. KSDE has requested a targeted poll of "j" or "m" codes. They are always a part of the data pull for districts but we are asking for more information on those two file types for indicator issues. This will give us information on serving all students.

Other technical assistance updates

- Dr. Geoff Colvin de-escalation webinar for Kansas.
- TASN KITS has been putting on Safety First Training
- Webinar will be coming out soon to help districts review data.
- CHAMPS trainer of trainers will come out this summer. Building on the work already started within the state.


ESI reporting – We are still in the first year that this has been required. First quarter reporting had difficulties. Reporting period 2 had 96% of districts reporting. Third quarter reporting ends today and we are hoping for another good reporting period.

A draft of an appeals process has been worked on by the DRC and KSDE's general counsel. When ESI regulations were adopted The State Board requested we investigate an appeals process and bring back a recommendation. What would a complaint process look like for dispute resolution? We do not have any extensive information today but would like to receive your input at future meetings.

- Is there data to suggest that we need to do something? We are only aware of 1 complaint that has gone to the district level at this time. This was resolved at the local level satisfactorily to the parent.
- Advice was shared by KSDE's legal counsel to bring both the law enforcement exemption and the appeals process regulation amendments to the State Board at the same time.

# **ESI** Role of Law Enforcement

Colleen and Jana recapped the discussion from the January SEAC meeting where information was provided from the Chief of Topeka Public Schools Police Department. In April discussion about the role of certified law enforcement continued, but no motion was made or vote taken. At that time, it was suggested that SEAC hold a conference call to allow a vote on the amendment for the role of certified law enforcement officers.

Part III of KAR 91-42-3 allows for the exemption for certified law enforcement officers from the regulations.

Part 6b – Outlines those exempted.

Reporting of the use of prone or supine restraints by law enforcement officers will be done through law enforcement reports and will not be reported by the quarterly reports on ESI completed by the schools, unless the school chooses to do so.

Matt Ramsey moved to approve the amendment to the regulations that would exempt certified law enforcement from the ESI regulations as stated in 91-42-3. Stacie Clarkson seconded the motion.

A roll call vote was conducted.

Motion carried.

How will the amendment to the regulations proceed? The first step will have Bryan and Colleen make a recommendation to the State Board of Education at the July meeting. Updates will be made to SEAC at the July meeting.
