

Resolution to Adopt Budget Second Publication - Property Tax Review

KSA 79-2925b requires school boards to adopt the budget by resolution *IF* the taxes levied will exceed the prior year by more than the consumer price index (CPI). In other words, if the 2nd publication is necessary, the board should adopt the budget by resolution (sample below). Include the Board of Education vote (i.e. Approved <u>7</u> Disapproved <u>0</u>) and Board Clerk's signature when the notice is published.
