The Local Consolidated Plan (LCP) Application for 2023-2024 is now open. The LCP Application is accessible through the KSDE authentication system at https://apps.ksde.org/authentication/login.aspx. Districts must submit the LCP Application before funds will be awarded. The due date for completing the application is Friday.. September 29, 2023.

After the login screen opens, one of the following will apply:

- <u>If you already have access to the LCP System</u>, click on the 'LCP System' link after you login. Click on this link to go to the LCP Application.
- Existing users that do not have the 'LCP System' listed as an available application:
 - Please go to <u>https://apps.ksde.org/authentication/login.aspx</u> and logon.
 - Then click on the 'Manage My Account' link, which is below the list of available applications and provide the requested information.
 - Select the 'LCP System' application and either the 'District Submit' (to update and submit for principals/superintendents) or 'District Update' (to update, but not submit – for other district personnel), then click 'Submit'.
 - After this information is received at KSDE, an approval request e-mail is sent to the Superintendent.
 - When the approval request form is completed and returned to the KSDE, the user information is entered into the system, and a confirmation e-mail is sent to the user.
 - Upon confirmation that the user information is registered, the LCP System is accessible.
- <u>First time users</u>:
 - Please go to <u>https://apps.ksde.org/authentication/login.aspx</u> and click on the 'Register' button and follow instructions.
 - Select the 'LCP System' application and either the 'District Submit' (to update and submit for principals/superintendents) or 'District Update' (to update, but not submit – for other district personnel), then click 'Submit'.
 - After this information is received at KSDE, an approval request e-mail is sent to the Superintendent.
 - When the approval request form is completed and returned to the KSDE, the user information is entered into the system, and a confirmation e-mail is sent to the user.
 - Upon confirmation that the user information is registered, the LCP System will be accessible.
