WHEREUPON the Professional Practices Commission (Commission) considered the matter on September 22, 2017. Michael Melcher appeared not. The Kansas State Department of Education appeared through its attorney, Kelli M. Broers. After reviewing the evidence, the Commission voted 7-0, to recommend the Board revoke Mr. Melcher's license.

WHEREUPON the Board reviewed the Commission's Initial Order and after considering the presentation by Linda Sieck, Commission Chair, who was available to answer the Board's questions and being otherwise duly advised in the premises, the Board adopted the Commission's findings of fact and conclusions of law by a vote of 10 - 0.

All findings set forth in the Commission's Initial Order attached hereto are incorporated by reference and made a part of this Final Order as though fully set forth at length herein.

IT IS THEREFORE CONCLUDED by the Kansas State Board of Education that Michael Melcher's license be revoked.

# BEFORE THE KANSAS STATE BOARD OF EDUCATION PROFESSIONAL PRACTICES COMMISSION

In the Matter of the License of Michael Melcher 17-PPC-25

#### INITIAL ORDER

The above-captioned case comes before the Professional Practices Commission (Commission) of the Kansas State Department of Education (KSDE) to determine whether Michael Melcher shall be subject to discipline up to and including revocation of his license.

This matter convened on September 22, 2017. Appearing for the Commission were Chairman Linda Sieck and members Laura Batson, Vici Jennings, John McKinney, Sylvia Ramirez, Maret Schrader, and Jessica Snider. Kelli Broers appeared as counsel for KSDE. Michael Melcher appeared not.

#### FINDINGS OF FACT

- 1. Michael Melcher, age 33, holds a Kansas professional teaching license, which is valid through April 20, 2018. His last known address is 301 E. Kansas Avenue Lansing, Kansas 66043.
- 2. On May 5, 2017, Melcher was convicted of felony sexual exploitation of a child in violation of K.S.A. 21-5510(a)(1)(b)(1)(B), Case No. 16 CR 507, Butler County District Court.
- 3. KSDE filed a complaint seeking the revocation of Melcher's license. It was mailed to his last known address at the Lansing Correctional Facility by certified mail, return receipt requested. It was delivered. Melcher did not file an answer and he did not request a hearing.

#### CONCLUSIONS OF LAW

1. The Kansas State Board of Education (State Board) is responsible for the general supervision of education, including the certification and licensure of teachers, in Kansas. K.S.A. 72-7513 and Kan. Const., Art. VI.

- 2. In Kansas, teaching and school administration are professions with all the similar rights, responsibilities, and privileges accorded other legally recognized professions. K.S.A. 72-8501. An educator is a role model. <u>Hainline v. Bond</u>, 250 Kan. 217, 224 (1992).
- 3. The Commission investigates and conduct hearings pertaining to allegations of misconduct. K.S.A. 72-8507; K.A.R. 91-22-1a et seq.
- 4. Mailing notice to a party's last known address is a permissible form of service. A written certificate of service is sufficient to presume service. Furthermore, service by mail is complete upon mailing. See K.S.A. 77-531.
  - 5. A party must request a hearing within 15 days of service of a complaint. K.S.A. 77-542.
- 6. A party has 20 days to file an answer upon receipt of a complaint. If no answer is filed, the person is deemed to have admitted the allegations contained in the complaint and to have acquiesced in the proposed action. K.A.R. 91-22-9.
- 7. The State Board may revoke the license of an individual convicted of a felony or any crime involving a minor. K.A.R. 91-22-1a(a)(1)&(2). It may also revoke the license of anyone who commits an act that injures the health or welfare of a child through sexual exploitation, regardless of whether a conviction results. K.A.R. 91-22-1a(a)(7). The State Board may also cancel a license on grounds of immorality. K.S.A. 72-1383.
- 8. The Commission, after reviewing the evidence in this matter and considering the applicable law, believes revocation of Melcher's license and any associated endorsements is necessary.

THEREFORE the Professional Practices Commission recommends to the State Board, by a vote of 7 - 0, that it revoke Michael Melcher's license.
