## **KESA 2.0 - The Model**

- One of our aims with KESA 2.0 is to make accreditation synonymous with school improvement, which would then result in **teachers being able to see their role clearly in the work of accreditation**. This is vitally important to ensure the work of accreditation is connected to the teaching and learning taking place in the classroom. To accomplish this, we are building a model where the external accountability inherent in accreditation reinforces the internal accountability educators feel to improve teaching and learning. In KESA 2.0, there will be a great deal of support and accountability in the 4 Fundamentals.

- This new accreditation model will be an **action-based model** with multiple checks for progress on a yearly basis. These “actions” systems take related to implementing the 4 Fundamentals are:
  - limited to a few
  - research-based
  - supported by KSDE

## **KESA Check-ins**

- What is a KESA Check-in?
  - A member of our Accreditation & Design team meets with a district’s KESA team on-site at the district’s location to discuss the system’s current continuous improvement process and student data as well as set the table for KESA 2.0 so each system has a clear understanding of the expectations for next year and the KESA 2.0 Yearly Support model.

- As of this communication, our A & D team has checked in with nearly 120 systems across the state. We appreciate the opportunity to sit down and have a conversation with each system. Our team regularly mentions how much they enjoy learning more about how systems are approaching continuous improvement and we are excited to be able to support each system in their efforts moving forward.

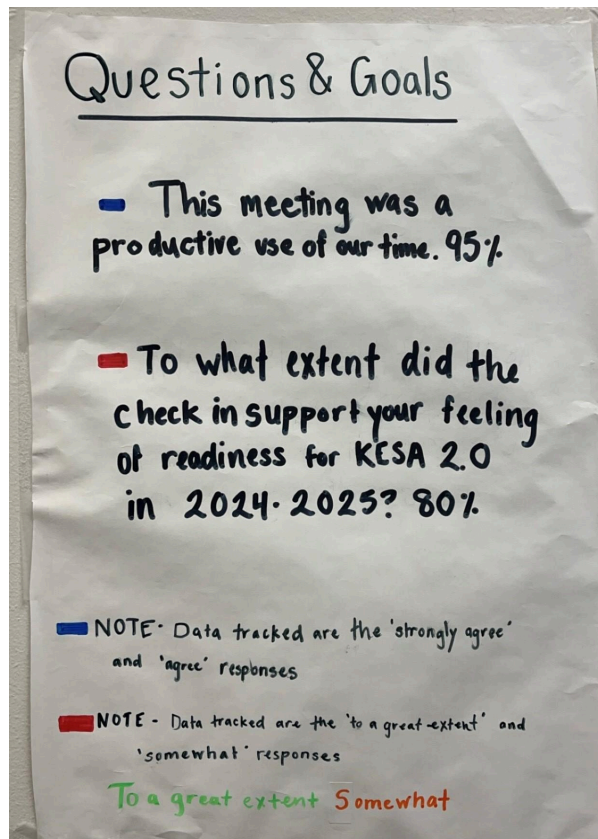

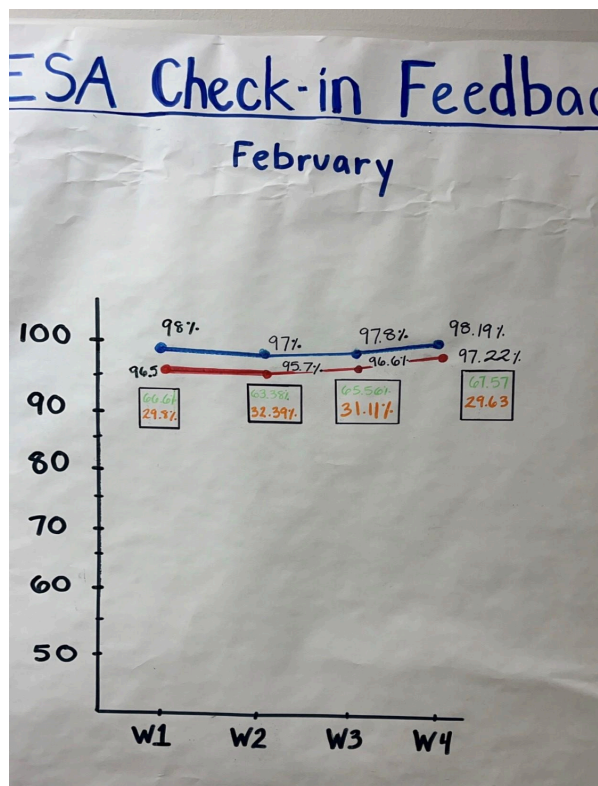
KESA Check-in conversations.

- We are collecting feedback from each system right after the Check-in to align and personalize our support of your system's improvement efforts, as well as improve the Check-ins moving forward. Our team is tracking the data from systems to all prompts, most especially the following:

1. **This meeting was a productive use of our time.**
2. **To what extent did the Check-in support your feeling of readiness for KESA 2.0 in 2024-2025?**

Here are snapshots of our weekly scoreboard displayed publicly in our Landon building office with the feedback from systems to the above prompts:





Another question we are asking of each system as part of the Check-in is prioritizing the 4 Fundamentals in terms of support needed from 1 (to a great extent) to 4 (not at all). The data below shows the most common rating for each fundamentals from the approximately 115 systems responding to the Check-in survey:

Fundamental	Most common rating of support needed  1 - to a great extent 2 - somewhat 3 - very little 4 - not at all
Structured Literacy	1 (30% of responses)
Standards Aligned	1 & 2 (each - 30% of responses)
Balanced Assessment	3 (35% of responses)
Quality Instruction	2 (32% of responses)

## **KESA 2.0 Build**

As we prepare to roll out KESA 2.0 in 2024-2025, these are the projects KSDE is undertaking this spring:

### **Priority Projects**

- Develop the School Improvement Model **Structures and Lead Indicators**.
- **Recruit and train facilitators** for the School Improvement Day which will include peer collaboration around data and the Four Fundamentals, and an action planning conversation.
- Design the **protocol for the deep dive into student performance data**.
- Integrate **Kindergarten Readiness** into the school improvement model and conversation.
- Integrate **Social and Emotional Learning** measured locally into the school improvement model and conversation.
- Integrate **Individual Plans of Study** into the school improvement model and conversation.
- Continue intentional **collaboration with Service Center and Technical Assistance Systems Network** partners.

## **2023-2024 KESA Peer Reviews**

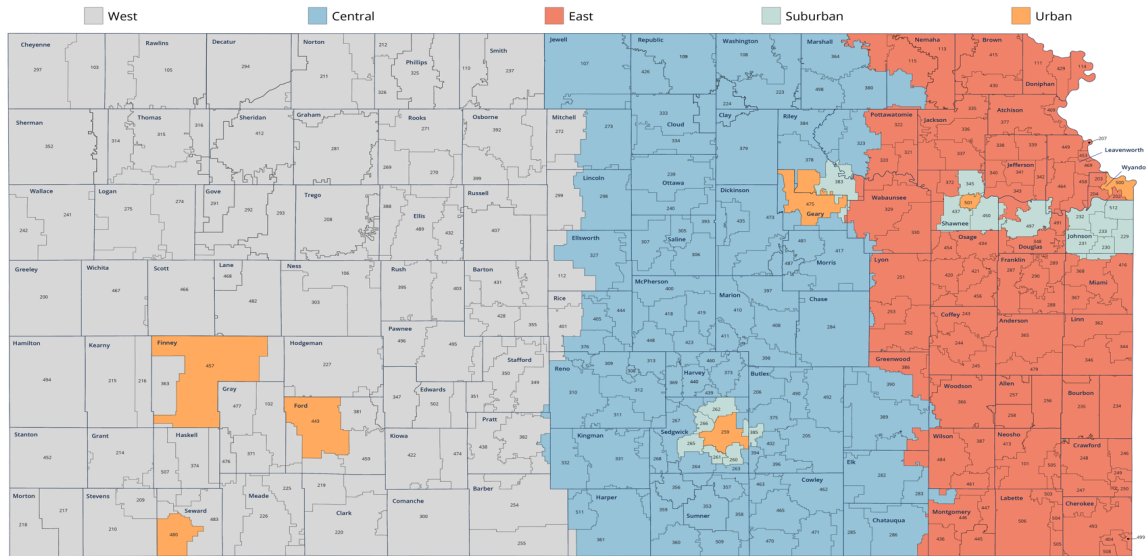
- Peer collaboration, when done well, is a critical component to continuous improvement. For the 2023-2024 school year, all systems have three options for a peer review (formerly OVT). During this Learning Year for KESA, as a transition, systems have the following options for a peer review:

1. Regional Peer Review
2. Traditional Peer Review
3. Like-system Peer Review



Each system is expected to participate and engage in at least one peer review session during 23-24 to discuss their current state in both student data and the Four Fundamentals. Here is a [sample agenda](#) for a Peer Review session this year.

# KESA Region/Cohort Model of Support
