Schedule a KSDE budget review

Before publishing the Notice of Hearing, many superintendents and business officials will request someone in the School Finance office double-check their budget document in July or August. You can visit KSDE in person, or mail a paper copy (see below).

Visit KSDE to have your budget reviewed - Please call to schedule an appointment:

If you plan to visit KSDE in person, please call to schedule a one-hour appointment with either Craig Neuenswander or Dale Dennis. Call School Finance and speak to Tamara at (785) 296-3871 or Sherry at (785) 296-3872 to determine a time.

The day of your appointment, please bring a printed copy of the budget (codes and forms) along with your laptop computer with the budget program. This will allow you to make revisions to your budget during the review.

Or mail KSDE a paper copy of your budget for a review by telephone.

To save the time/cost of driving to Topeka, mail a paper copy of your budget (codes and forms) and our office will review your budget and call you - no appointment necessary. Generally, a mailed-in budget is reviewed within 24 hours of receipt.

Because a high number of districts that visit KSDE in person during office hours, we often review the mail-in budgets after 5 p.m. To help us reach you, please include a cell or home phone number, in addition to your office number.

Print only the funds (codes) and forms (Form 110, 150, etc.) being used.

MAILING INSTRUCTIONS:

Include a cover letter with your budget:

- 1. explain any specific problem area(s) to be reviewed
- 2. provide contact name(s)
- 3. office phone (first attempt) and home/cell phone number
- 4. If time is critical, provide the "latest date" we can return a call to your office. This might be just prior to your board meeting. Allow time to make any changes and publish the Notice of Hearing.

Also, if you had already scheduled a one-hour time slot to visit the KSDE office, please indicate the date and time of your appointment with the mail-in budget.

What we check on the budget document:

- 1. Form 150 Weightings are in line with prior year.
- 2. Form 150 Special Education state aid is high enough.
- 3. Form 110 Percent of collection (same for each fund)
- 4. Form 110 Delinquent tax rate is included.
- 5. Motor vehicle taxes are similar to prior year.
- 6. Code 99 Amounts budgeted are the same as the individual funds.
- 7. Code 01 Amounts are the same as Code 99 and individual funds.
- 8. Bond and Interest Cash balance is stable.
- 9. Bond and Interest fund Cash flow is adequate.
- 10. Capital Outlay fund Revenue and expenditures balance in Column 4.
- 11. Resolutions for levy limits have not expired.
- 12. Special funds Are they budgeted high enough?
- 13. Special funds Cash balances are about the same.
- 14. Special funds Revenues are similar to prior year.
