WHEREUPON the Professional Practices Commission (Commission) considered the matter on April 26, 2019. David Porter did not appear. The Kansas State Department of Education appeared through its attorney, Scott Gordon. After reviewing the evidence, the Commission voted 8 – 0, to recommend the Board deny the application of David Porter for an emergency substitute license.

WHEREUPON the Board reviewed the Commission's Initial Order and after considering the presentation by Linda Sieck, Commission Chair, who was available to answer the Board's questions and being otherwise duly advised in the premises, the Board adopted the Commission's findings of fact and conclusions of law by a vote of 10 - 0.

All findings set forth in the Commission's Initial Order attached hereto are incorporated by reference and made a part of this Final Order as though fully set forth at length herein.

IT IS THEREFORE CONCLUDED by the Kansas State Board of Education that David Porter's application for an emergency substitute teaching license is denied.

# **INITIAL ORDER**

The above-captioned case comes on for hearing before the Professional Practices

Commissioner (Commission) of the Kansas State Board of Education (State Board) upon the

Complaint filed by the Kansas State Department of Education seeking denial of David Porter's application of an emergency substitute license.

The hearing on this matter was held on April 26, 2019. Appearing for the Commission were chairperson, Linda Sieck, and members, William Anderson, Aaron Edwards, Jennifer Holt, Nathan Reed, Sylvia Ramirez Stan Ruff, and Maret Schrader. The KSDE appeared by and through its attorney, General Counsel, R. Scott Gordon. David Porter did not appear.

## **FINDINGS OF FACT**

- 1. David Porter applied for an emergency substitute license. He is not currently licensed.
- 2. On August 6, 2012, Mr. Porter was charged with one count of misdemeanor Possession of a Hallucinogenic Drug as described in K.S.A. 21-5706(b)(3); and two counts of Possession of Drug Paraphernalia as described in K.S.A. 21-5709(b)(2) in Mitchell County District Court, all of which occurred on July 22, 2012.
- 3. On August 9, 2012, Mr. Porter entered into a Diversion Agreement with the Mitchell County Attorney's Office whereby he agreed to comply with certain terms of his diversion to avoid criminal prosecution. Within that diversion agreement, Mr. Porter admitted to having possessed a hallucinogenic drug and drug paraphernalia. Mr. Porter successfully completed diversion on February 1, 2013.

- 4. On September 7, 2018, Mr. Porter was charged with one count of misdemeanor Possession of Marijuana as described in Section 9.9.1 of the Uniform Public Offense Code for Kansas Cities; and one count of misdemeanor Possession of Drug Paraphernalia as described in Section 9.9.2 of the Uniform Public Offense Code for Kansas Cities in the Municipal Court of the City of Beloit, Kansas, both offenses occurred on August 26, 2018.
- On September 10, 2018, Mr. Porter pleaded guilty to and was convicted of one count of misdemeanor Possession of Marijuana and one count of misdemeanor Possession of Drug Paraphernalia.
- 6. The Kansas State Department of Education mailed a copy of the Complaint via certified mail to David Porter's last known address. It was delivered February 20, 2019. Mr. Porter did not request a hearing nor did he submit an Answer to the Complaint.

## CONCLUSIONS OF LAW

- The Kansas State Board of Education (State Board) is responsible for the general supervision of Kansas education, including the certification and licensure of teachers. Kan. Const., Art. VI and K.S.A. 72-255.
- 2. The State Board may deny an application for license for conviction of any misdemeanor involving drug-related conduct as provided for in K.A.R. 91-22-1a(a)(4) and (b).
- One of the obvious goals of education is to "instill respect for the law." Hainline v. Bond, 250
   Kan. 217 (1992). An educator is a role model. Hainline at 224.
- 4. Teaching and school administration are professions with all the similar rights, responsibilities and privileges accorded other legally recognized professions. K.S.A. 72-2308.
- 5. David Porter's conduct is inconsistent with the commonly-held perceptions and expectations of a member of the teaching profession. Such conduct violates the public trust and confidence placed in members of the profession. Mr. Porter's conduct demonstrates a lack of fitness to

perform the duties and responsibilities of a member of the teaching and school administration professions and is sufficient and just cause to deny his application for license.

THEREFORE the Professional Practices Commission, by vote of 8-0, recommends the Kansas State Board of Education deny the application of David Porter for an emergency substitute license based on his conviction of misdemeanor drug charges, and for not requesting a hearing or submitting an answer in response to the Complaint.
