Based on the work Teacher Licensure Director has done with the ISU Registrar's office in settling this issue of how Albion Center credits relate to semester hours, the Registrar has provided documentation that allows KSDE to accept (.5) semester hours of college credit for every one hour of graduate, non-degree, professional development credit issued through the Albion Center.

For my final reviews of PD plans, I am scheduling in-person/Zoom calls. So whether you've received a few reviews or not been reviewed yet, please fill out the following survey for times you are available to meet with me to work through your PD Plan.

Here is the process:

- You will send me the above survey with your available times/dates.
- I will schedule the Zoom call and send the information to you. Or we may do it in-person if that is possible.
- We will meet. I have scheduled one hour, but I am open for two if you want and can continue the discussion. I also have only sent this survey to only you in your district/system so feel free to invite anyone else who will have something to contribute to the meeting.
- You will do the following within the 20 working days our meeting:
  - Make the changes we discussed at our meeting.
  - If you would like me to accept those changes before you go to the PDC for approval of the plan, we can arrange to do that.
  - If you are comfortable that everything you need to change will work, you can take the plan to the PDC for its approval. When there is a motion to approve, you may ask that the motion include the minor changes that may come up with KSDE's final viewing of the plan.
  - Once the PDC approves the plan, you will send it to me.
- I will put the plan on the State Board of Education's meeting agenda for the following month.
- I will inform you when the approval vote is scheduled. The approval on these plans is usually part of the consent agenda. However, since it has been a few years since the Board has seen any, they may pull them for discussion.
- Finally, I will let you know when you plan is approved or of any other action the Board requests that we take."

Educator Preparation is seeking reviewers to serve on review teams for higher education preparation programs for each license and endorsement area, especially Agriculture, Art, Business, Driver Education, Earth and Space Science, English for Speakers of Other Languages, English Language Arts, Gifted, Mathematics, Music, Physics, School Psychologist, Speech/Theatre, Technology, and World Languages. Reviews are held throughout the academic year, and consist of one team meeting plus follow-up team discussion by email for each review.

Program Review is vital to maintaining strong teacher preparation in Kansas. Institutions must have peer-reviewed and approved programs for all areas for which they wish to make licensing and endorsement recommendations. Each KSDE-accredited teacher preparation institution's programs are reviewed on a 7-year cycle, with program reviews held 18 months in advance of the unit's accreditation visit. Institutions may propose new programs at any time in their accreditation cycle.

Reviewers thoroughly examine the key assessments, scoring guides and rubrics, data and other supporting documents of a teacher preparation program in their content area, and work with fellow team members to determine whether the program meets each of the Kansas licensure program standards for that area, write any Areas for Improvement (AFIs), and complete a program review team report using a provided template. Training is offered every Fall, as well as a refresher at the beginning of each review.

Reviewers are reimbursed for travel and tolls (with receipt), overnight stay if necessary for travel more than 150 miles one-way, and a substitute teacher if necessary. Reviews are also help virtually by Zoom.

**Update: September 27, 2022**

The template for PD plan reports is scheduled for introduction on October 3, 2022. It will include guidance on how to update the plan and the template layout to write the plan. Use of the layout will be optional; however, it will include report sections (selecting PDC membership, updating the PD plan, etc.) and minimum content that are required.

The second week of Zoom sessions last week to discuss and get input for the template went well. After discussing how PD Plans are created and what Individual Professional Development Plans should look like, I started working on the actual document. Instead of just being a template, it became a template with guidance. Also, there is the template by itself to help with the actual production of the PD Plan.

This week I have sent out a few drafts others to peruse and for comments. On Wednesday the 28th, we will have two Zoom calls for more input. Thursday will be for finalizing the content and finishing the formatting for the unveiling by the close of business on October 3rd.

**Update: September 19, 2022**

The template for PD plan reports is scheduled for introduction on October 3, 2022. It will include guidance on how to update the plan and the template layout to write the plan. Use of the layout will be optional; however, it will include report sections (selecting PDC membership, updating the PD plan, etc.) and minimum content that are required.

The first week of Zoom sessions last week to discuss and get input for the template went well. After discussing how districts select their PDC members and how some of the details did not meet the regulation, we came up with some options to adjust current practices. Also, in some



of the plans I have reviewed, some elements of what should be in the PDC operation standards were not included. The template will provide a list of those minimum elements.

This week the big topic will be developing and maintaining the PD plan itself, including PD needs assessment, goals and objectives, activities, and evaluation criteria. I plan to send out a draft next week to those involved, if time allows, for final input.

#### **Update: September 12, 2022**

I have scheduled six, hour-long Zoom sessions with districts/systems who have plans in review for this week and 6 for next week to get input about PD Plans and a PD Plan template and guidance. This week all the sessions are the same and will cover the layout of the plan, its introduction and the PDC and its operation. Next week each session is the same and will cover the PD Plan itself, individual development plans and miscellaneous plan sections.

This process is meant to make writing and reviewing PD Plans more consistent and quicker in the future. If a district/system has already received the KSDE review report, it does not have to use the new template but can just respond to the review report as originally requested.

However, the new template will also have more details about plan content and may help keep the number of revisions to a minimum.

Also attached is the revised timeline. I will need at least 30 days from the final due date to be able to review your final drafts.
