July 1, 2016	FY 2017 Perkins Improvement Grants status letters sent to recipients. Note: Grant recipients receiving full or substantial approval can begin
August 24, 2016	Revisions for FY 2017 Perkins Improvement Grants final approval are due electronically. Note: Submission must include the entire grant application, not just the changes.
September 7, 2016	FY 2017 Carl D. Perkins Improvement Grant final approval letters will be sent to recipients
September 15, 2016	Perkins first draw-down request on Form 240 for an October 1, 2016 payout.
October 14, 2016	Districts/Consortiums chosen for a monitoring visit of FY 2016 Perkins funds are notified.

October 30, 2016	KSDE - Narrative Draft for Consolidated Annual Report (CAR) due for 2016 (<u>STATE LEVEL REPORT ONLY</u>)
November 1, 2016	First FY 2017 Carl D. Perkins Grant Progress Reports are due.
November 11, 2016 (<i>Tentative</i>)	Perkins Webinar Monitoring Training for districts/consortiums chosen for a monitoring visit of FY 2016 Perkins funds. (1:30 to 2:30 p.m.)
November 15, 2016	Pathways Web Application opens to initial submission of New and Maintenance CPPSAs. The deadline to complete this is March 15, 2017.
November 30, 2016	KSDE - Perkins Student/program data and Budget information for CAR due to KBOR (<u>STATE LEVEL REPORT ONLY</u>)
December 1, 2016	Equipment for Perkins grant must be purchased or encumbered. Prior approval required!
December 15, 2016	KBOR submits CAR report to federal office. (<u>STATE LEVEL ONLY</u>)
February through April, 2017	Perkins on-site monitoring visits of FY 2016 Perkins funds will occur.
February 17, 2017 (<i>Tentative</i>)	Perkins IV Update - Webinar (2 of 2) – 1:30 to 2:30 p.m.
March 1, 2017	Second FY 2017 Carl D. Perkins Grant Progress Reports are due.
March 15, 2017	Pathways Web Application closes to initial submission of New and Maintenance CPPSAs.
March 15, 2017	Deadline to submit Pathway Deletion Forms for following school year.

July 1, 2017	Final letters of approval for the 2018 Perkins IV Local Plan and Application sent to districts
July 1, 2017	2018 Perkins Grant award year begins.
August 15, 2017	Pathways Web Application closes to assign teachers and students to pathways.
