MEMORANDUM OF AGREEMENT

THIS ARTICULATION AGREEMENT is between any Kansas High School students who have successfully completed a state approved **Visual Arts-Graphic Design Strand Career Cluster Pathway and Flint Hills Technical College, Emporia, Kansas**. It will provide students with the smooth transition from high school a postsecondary program with an option to earn a certificate in **Graphic Arts Technology**. The intent of this cooperative effort is to provide the students with a non-duplicative program of study to enhanced employment opportunities.

NOW, THEREFORE, it is agreed by and between the parties as follows:

1. The awarding of articulated credit is contingent upon the graduating high school's continuance of their KSDE approved Career Cluster Pathway.
2. The secondary student will attain concentrator status through successful completion of his/her high school Career Cluster Pathway sequence of courses.
3. The corresponding Kansas High School will provide the courses listed on the attached Program of Study/Course Sequence form.
4. Flint Hills Technical College will provide the courses listed on the attached Program of Study / Course Sequence form.
5. Successful completion of the following Visual Arts Career Cluster Pathway course(s) will result in the student being awarded college credit for the equivalent course(s) listed:


6. Postsecondary Credit will be granted to the student upon submission, by the student, of the high school transcript to Flint Hills Technical College.
 - a. Credit will only be awarded for a grade of C or better
 - b. Credit will be granted at the time of enrollment (students must contact the Registrar).
7. To receive a certificate, students must complete all graduation requirements of Flint Hills Technical College.
8. *Flint Hills Technical College* any high schools offering the approved Career Cluster Pathway may advertise the programs and will jointly advise the students that this option is available to them.
9. This agreement may be revised by mutual agreement and shall be modified in the event of cancellation, discontinuance or disapproval of any course or program by the Kansas State Board of Education.
10. The college agrees to evaluate this program on an annual basis and in the context of student benefits, program efficiency, and effectiveness.

11. Any change in high school or college staff related to this agreement must result in a review of the agreement or the agreement may be considered void.
12. This agreement shall begin March 1, 2014.
13. This agreement is subject to change or cancellation by the Legislature at any time in accordance with Article 6, Section 5 of the Kansas Constitution.
