- Postsecondary Retention
- ACT/SAT College Readiness Assessment

Postsecondary is defined as work-force, military, certification programs and institutes of higher education.

### Predictors of Postsecondary Success Reporting

Industry Recognized Certification: District and building K-PAC Report

Pathway Completion: Number of student "completers" as per Pathways Report

AP: Number of exams taken and passing rate

Postsecondary Enrollment: % of students who enroll within 16 months of graduation

Postsecondary Retention: % of students who complete 24 non-remedial credit hours within 24 months of post-secondary enrollment

ACT/SAT: District and building averages

- Dual Credit earned in high school
- International Baccalaureate (IB) courses completed in high school
- Kansas Board of Regents Qualified Admissions completers
- Internship and/or Work Study completed during high school
- Civic Engagement/Volunteerism
- Individual Plan of Study aligned with student career interest
- Student EXIT record declaration of post-secondary plan
- Armed Services Vocational Aptitude Battery (ASVAB) pass rates
- Reserve Officer Training Corps (ROTC) participants
- 8<sup>th</sup> grade Algebra I completers
- High school Science, Technology, Engineering and Mathematics (STEM) course completion
