National Meeting Notes:

- 1. 1 of 4 Compacts adopted by all 50 states plus 1 (D.C.) (KS was 1^{st} ; 4/9/08)
- Annual Business Meeting Colorado Springs
 The state commissioners spent day one reviewing policies in place for MIC3, along with expectations
 and the election process.
 - a. Executive Committee Elections
 The chair and vice chair typically serve two-year terms, and remain the same as last year:
 Chair Don Kaminar from Arkansas
 Vice-Chair Laura Anastasio from Connecticut
 Bob Buehn has served as treasurer for the past six years and decided to step down. Craig
 Neuenswander was elected to serve as the new treasurer. He is excited to serve at the national
 level and will have an opportunity to better serve Kansas on military compact issues.

b. MIC3 Strategic Plan – new goals

Goal 1: Clarity and Awareness

Are military families aware the Compact exists, why we exist, and how we can help them? Can the Dept of Defense play a role emphasizing the MIC3 and increasing awareness?

Kansas had no student issues reported to National Office. Kansas does a great job at the local level and there usually isn't a need to contact the state or national office for help.

The legislature is also aware of the important role of military families in our state and typically are supportive and willing to help.

Keith (Ft Leavenworth) is working with Mischel Miller (KSDE Director of Teacher Licensure) to help military spouses with teaching license reciprocity if they hold an active out-of-state teaching license in good standing so they can start teaching immediately while living in Kansas. The current teacher licensure process is lengthy and can eliminate a whole school year waiting to become licensed in Kansas.

Goal 2: Cohesive and Aligned

How well do we function at the national level as an organization of all states working together?

Goal 3: Foundation and Future

The finance committee will address revenue resources. FTE has been steadily declining, which leads to a decline in dues. Last year the state dues amount per student was increased after 10 years with no change.

c. Children of National Guard and Reserve

The question of when the Compact should serve students whose parent serves in the National Guard and Reserve is being discussed at the national level. Compact rules currently state that we help only when the parent is on active duty. There could be issues needing attention at other times when the Compact could assist. A committee has been formed to look at this issue and determine how to best represent these military students and families.

Temporary housing at enrollment

Some families returning from overseas hand carry school records to expedite enrollment. Temporary housing arrangements can create problems when trying to enroll in the district they want to attend.
