- Web applications are reports submitted to KSDE through an authenticated submission website.
- When web applications are available for data entry, KSDE will send a listserv message which will provide instructions how to submit your data to KSDE online and when it is needed.

- An individual login and password is needed to access each report. New staff members are required to register and be approved by the superintendent before gaining access to enter or review data.

Accreditation Licensure Waiver (Form 16) Certification of Staff –

Accreditation Licensure Waiver (Form 16) applications should be received in the office of **Teacher Education and Licensure, Kansas Department of Education, by November 1.**



If a district hires or reassigns a person requiring a waiver after the start of the school year, and the individual cannot meet the current enrollment requirement until second semester, the completed waiver request must be submitted by **February 1** of the current academic year.
