Directions to the Learning Center from the North

1. Follow US-75 South across the Kansas River (Westgate Bridge).
2. Take I-70, East, to the MacVicar Exit 359
3. Turn Right (South) on MacVicar street.
4. Proceed on MacVicar to 2nd Street.
5. Turn Right (West) on East Circle Drive South.
6. The Learning Center is on the NW corner.
7. Parking is available in front of the building and the lots just to the south of the Learning Center.

Directions to the Learning Center from the South (US Highway 75)

1. When you arrive at I-470, take the I-470 West exit.
2. Turn East on I-70 (toward Kansas City).

6. Turn Right (West) on East Circle Drive South.
