Appearing for the Board are Chairman, Jim McNiece, and members, Kathy Busch, Carolyn Wims-Campbell, Sally Cauble, Deena Horst, Jim Porter, Steve Roberts, Janet Waugh, and Ken Willard.

WHEREUPON, a complaint was filed by the Kansas State Department of Education and Mr. Hobbs had the opportunity to respond to the complaint. Mr. Hobbs did not respond to the complaint. The complaint and supporting evidence were reviewed by the Professional Practices Commission (Commission).

WHEREUPON the Board reviewed the Commission's Initial Order and Mr. Hobb's subsequent submission of a voluntary surrender of his license and after considering the presentation by Linda Sieck, Chairman of the Commission, who was available to answer the Board's questions and being otherwise duly advised in the premises, the Board adopted the Commission's findings of fact and conclusions of law by a vote of 9 - 0.

All findings set forth in the Commission's Initial Order attached hereto are incorporated by reference and made a part of this Final Order as though fully set forth at length herein.

IT IS THEREFORE CONCLUDED by the Kansas State Board of Education that Matthew Hobbs's license and any endorsements shall be revoked.

# DEFORE THE KANSAS STATE BOARD OF EDUCATION PROFESSIONAL PRACTICES COMMISSION

In the Matter of the Professional License of Matthew Hobbs 15-PPC-34

#### INITIAL ORDER

The above-captioned case comes on for hearing before the Professional Practices Commission (Commission) of the Kansas State Department of Education (KSDB) for consideration of Matthew Hobbs's teaching license.

The hearing on this matter convened on August 5, 2015. Appearing for the Commission were chairperson, Linda Sicok, and members, Dorsey Burgess, Tavis Describers, Kimberly Groom, Justin Henry, John McKinney, Bradley Nicks, and Jessica Snider. Kelli Broom appeared as counsel for KSDB. Matthew Hobbs did not appear.

#### PINDINGS OF FACT

- 1. Matthew Hobbs has been ilcensed as a Kansas teacher since 2006. His license is scheduled to expire on October 21, 2017.
- 2. On September 12, 2014, Mr. Hobbs was charged with felony Unlawful Sexual Relations in violation of K.S.A. 21-3520(a)(8) for engaging in consensual lewel fondling or touching while he was a teacher at Andover Middle School and the viotim (DOB 6/10/1992) was a student at Andover High School. The conduct occurred between November 1, 2009, and June 20, 2010.
- 3. On April 24, 2015, an Amended Information was filed and Mr. Hobbs was charged with misdemeaner Sexual Battery in violation of K.S.A. 21-3517. That same day he entered a plea agreement wherein he agreed to plead no contest to the Sexual Battery charge.
- 4. Ultimately, Mr. Hobbs was sentenced to 12 months in Jall, which was stayed as the court granted him probation of 12 months. Mr. Hobbs was required to register as a sex offender.
- On May 26, 2015, KSDB asked Mr. Hobbs to voluntarily surrender his license by July 1, 2015, and received no response.
- KSDB filed a Complaint pursuant to K.A.R. 91-22-5a on July 7, 2015. That Complaint
  was placed in the mail on July 8, 2015, by certified mail, return receipt requested. The
  Complaint was signed for on July 10, 2015.
- 7. Mr. Hobbs did not request a hearing, nor did he file an answer to KSDB's Complaint.

#### CONCLUSIONS

- 8. If no answer to a Complaint is filed within 20 days, the Applicant is deemed to have admitted the allegations contained in the Complaint and acquiesced in the proposed action. K.A.R. 91-22-9.
- Pursuant to K.S.A. 72-8501, the Legislature has declared teaching and school administration
  to be professions in Kansas with all the similar rights, responsibilities and privileges
  accorded other legally recognized professions. An educator is in a position of public trust.
- 10. Any license issued by the State Board may be canceled by the State Board in the manner provided by law, on the grounds of immorality or for any cause that would have justified the withholding thereof when the same was granted. K.S.A. 72-1383.
- 11. It is within the authority of the State Board to adopt rules and regulations providing for the issuance, renewal, reinstatement and revocation of a license to teach.
- 12. The State Board cannot knowingly issue or renew a license to someone convicted of Sexual Battery in violation of K.S.A. 21-3517 when the victim is a minor. K.S.A. 72-1397. The State Board may cancel any license for any cause that would have justified the withholding thereof when the same was granted. K.S.A. 72-1383.
- 13. A license may be revoked by the State Board for misconduct or other just cause including any orime involving a minor, commission of any act that injures the health or welfare of a minor through sexual abuse or exploitation, or engaging in any sexual activity with a student, K.A.R. 91-22-1a.
- 14. Mr. Hobbs's sexual misconduct with a minor student and his subsequent conviction for Sexual Battery and registration as a sex offender are grounds for revoking his application.

THEREFORE the Professional Practices Commission recommends, by a vote of 8-0, subject to the State Board's review, that Mr. Hobbs's application should be denied.
