# Board of Emergency Medical Services (BEMS)

- Teacher Requirements

- EMR - Instructor must be an EMT or above, a nurse or physician, and be certified as an Instructor-Coordinator through the BEMS.
- EMT - Instructor must be an EMT or above, a nurse or physician, and be certified as an Instructor-Coordinator through the BEMS.

**After January 1, 2022, the requirement of certified Instructor-Coordinator changes to the sponsoring organization must select qualified instructors as determined by training and knowledge of subject matter:**

- **Didactic and medical skills instructors must possess certification, registration, or licensure in the subject matter or medical skills being taught**
- **Nonmedical skills instructors must have technical training in and possess knowledge and expertise in the skill being taught**
- **Clinical instructors in a clinical health care facility must be a licensed physician or a licensed professional nurse**
- **Field internship instructors in a prehospital EMS service must be an EMS provider certified at or above the level of training to be conducted**

CTE also can help all students achieve the objectives of the Kansas College and Career Ready Standards (KCCRS) through authentic, applied learning experiences. In short, CTE is a crucial change agent for the success of improving outcomes for all students.

Kansas utilizes the National Career Clusters® Framework. Technological advances and global competition have transformed the nature of work. Tomorrow's jobs will require additional knowledge, improved skills and highly flexible workers who continually update their knowledge and skills. Career Clusters link what students learn in school to the knowledge and skills they need for success in post-secondary education and careers.
