KESA 2.0 proposal to State Board of Education

On Tuesday, December 12th, KSDE's School Improvement Workgroup proposed to the State Board of Education a new model of accreditation, KESA 2.0. Here are the slides presented. Below is a summary of what was proposed and the State Board of Education's action:

- KSDE asked the State Board to approve the following for KESA 2.0
 - the Four Fundamentals as a basis for being accredited as a K-12 system.
 - the Annual Accreditation System.
- KSDE also provided context to the KESA 2.0 model, including:
 - the tools/resources KSDE would develop to support systems in the Four Fundamentals this spring.
 - a list of projects that would be part of the "build" of KESA 2.0.
 - a hypothetical example of when a system would be in need of an ARC review or not.
- The State Board of Education voted unanimously to approve the parts of the KESA model established to date but also included in the motion that a second approval would be required in late spring/early summer once the model is more fully developed.


KESA Check-ins (beginning mid-January 2024)

As part of our new regional/cohort model of support for KESA, we are adding a KESA Check-in that begins this January and will remain in place for KESA 2.0. The KESA Check-in is:

- an annual engagement where a member of the Accreditation & Design team meets with a system's KESA team in-person at the system's location.
- an opportunity to develop a stronger relationship between KSDE and the system focused on continuous improvement.
- intended to support the system in staying on track with their action plan for KESA, as well as a time to review the system's student outcomes.

The Accreditation & Design team is excited to begin these Check-ins in January! We have sent out meeting invitations to every system that had responded to the KESA Check-in/Peer Review survey. KESA Region/Cohort Model of Support
