## **PACK Act Basics**

- HB 2466
  - (<u>http://www.kslegislature.org/li\_2022/b2021\_22/measures/documents/hb2466\_enrolled.pdf</u>)
- Enrolled 7/1/2022
- CS
  - Requires public high schools to offer CS ("shall offer" not "shall require")
  - \$1 million for in-service teacher PD (renewed in budget bill for 2023-24)
  - Scholarships for pre-service teachers
  - Reporting (Grantee to KSDE and KSDE to Governor and Legislature)

# **Current PACK Act Activity**

- 3 grantees for professional development
  - K-State
  - WSU Tech
  - ESSDACK
- Offering a course that meets the Kansas P12 Computer Science standards is NOT optional
- If a school cannot offer one, they MUST submit a plan to KSDE

# Academics vs CTE

- Significant overlap in topics
- Graduation requirements
  - HS Diploma "meaning"
  - Core vs electives
  - Changes
- Measuring academic achievement
  - "Rigor"
- Proving teacher confidence and competence
- Funding
- Advance credit matriculation

# **Course Topics**

- Computer Programming
- CS Applications (NOT the same as Computer Applications)
- CSP
- Cybersecurity
- Web design
- Networking / Internetworking
- Data Science

# Academics vs CTE

### PACK Act Req.

- Each Secondary School must offer
- No requirement for students to take
- Academic course, teacher licensed at grade level
- Must meet or exceed part of CS Standards

### **Graduation Req.**

- Each Secondary School
  must offer
- All students must take
- CS MAY count as math or science credit OR advanced STEM
- CTE IT courses must be application level to count for adv STEM

### **CTE** Pathway

- Each Secondary School may offer
- Students take to become completers
- CTE course, teacher CTE licensed
- 4 IT pathways
- Based on local B&I needs

# **Teacher Qualifications**

- Course teacher of record must meet one of two requirements
- Course in CTE pathway: teacher must hold
  - CTE licensure appropriate to course content; or
  - Licensure at grade level plus training according to Licensed Personnel Guide Part 5
- Course not in CTE pathway: academic teacher must hold
  - Licensure at grade level
  - CS endorsement does not currently exist

# **Course Funding**

- CTE: +.5 FTE additional funding (for tech and application level only)
- CTE funding cannot be used on course that is a graduation requirement (additional funding for "special" courses, not additional revenue stream for district generated by all students)
- Course expenses vary per topic and vendor

# Matriculation to Postsecondary

- Academic course
  - Dual credit, based on
    - Specific course
    - Specific teacher's qualifications
    - Specific postsecondary institution
  - AP exam, based on
    - Specific course
    - College Board qualification
- CTE course
  - Dual credit
  - CTE articulation agreement (statewide or local)
