#### November State Foundation Aid

Districts will notice a slight increase in the State Foundation Aid payment, which deposited Monday, November 2, in comparison to the amount reflected on the LEA Forms – State Aid Request for November (web application). The amount reflected on the Kansas e-Supplier Portal and School Finance Payment Information website is the actual payment that was deposited and should be recorded in your accounting system.

We use two separate systems to generate the payment and each used a slightly different percentage for the calculation. Your total state foundation aid for the year will not be impacted by this change. We apologize for any inconvenience.

## Early Retirement Survey due Nov 17 (Interlocals and coops may disregard)

Every year, KSDE collects an early retirement survey from <u>all school districts</u>. Kansas Statute <u>K.S.A. 72-2291</u> provides that school districts with early retirement incentive plans must submit a budget report to the State Board of Education. Survey data will be reported to the Legislative Joint Committee on Pensions, Investments and Benefits for their review. *Even if your district does not currently offer an early retirement program, please return a survey form with the NO box checked*.

Answer question 1: Do you have an early retirement program in your district?

- 1. If an *ER plan is not offered*, download the form, enter your USD number, check the **NO** box, and print. Sign, convert to a pdf doc and submit.
- 2. **If your ER program was** <u>discontinued</u>, but benefits continue to be paid, check the **NO** box and:
  - a. on guestion 7, state the year the ER incentive program was stopped; and
  - b. on questions 2, 3 and 4, enter cost of ER benefits, and number of retired employees that will continue to receive benefits.
  - c. Save, print, sign, convert to a pdf doc, and submit.
- 3. If you *currently offer an ER program*, check the **YES** box <u>and</u>:
  - a. answer questions 2-7. For all years shown, enter total number of employees receiving benefits and associated costs (actual and estimated).
  - b. Save, print, sign, convert to a pdf doc, and submit.
