# **Every Student Succeeds Act (ESSA)**

• On December 10, 2015 President Obama signed into law the Every Student Succeeds Act (ESSA), which reauthorizes the Elementary and Secondary Education Act of 1965 (ESEA). This latest update, will revise provisions in the No Child Left Behind Act of 2001. The ESSA includes many reforms that return returns flexibility to the state while maintaining accountability for the success of all children.

# Title VI Indian, Native Hawaiian, and Alaska Native Education

- Reauthorized for 2017-2018 school year
- Formerly Title VII

- Districts apply directly to USDE
- Minimum of 10 students

# **Title VIII General Provisions**

- Reauthorized for 2017-2018
- Formerly Title IX

- Provides definitions of many terms (MTSS, Evidence Based Practices, etc.)
- -Ombudsman requirement for private schools



# **Use of Evidence Based Intervention Required**

- Most activities funded through ESSA must now be evidence based, as defined by the law:
- (i) demonstrates a statistically significant effect on improving student outcomes or other *relevant outcomes* based on-
- (I) *strong evidence* from at least one well-designed and well-implemented experimental study;
- (II) moderate evidence from at least one well-designed and well-implemented quasi-experimental study; or
- (III) *promising evidence* from at least one well-designed and well-implemented correlational study with statistical controls for selection bias; or
- (ii) (I) *demonstrates a rationale* based on high-quality research findings or positive evaluation that such activity, strategy, or intervention is likely to improve student outcomes or other *relevant outcomes*; and
- (II) *includes ongoing efforts to examine* the effects of such activity, strategy, or intervention.

- Math-3<sup>rd</sup> through 8<sup>th</sup> grades, plus once in high school
- ELA-3<sup>rd</sup> through 8<sup>th</sup> grades, plus once in high school
- Science once in each grade span, 3-5, 6-8, and 9-12.

# **Accountability System Requirements**

Each statewide system will "meaningfully differentiate" schools using:

- 1. Academic proficiency on state assessments
- 2. Graduation rates for high school
- 3. English Language Proficiency
- 4. Growth or another statewide academic indicator for K-8 schools
- 5. Not less than 1 other state-set indicator of school quality or student success
- 6. 95% assessment participation rate.
- "Substantial weight" is required to be given the Academic Indicators (first 4 described above) and these 4 indicators must, in the aggregate be given "much greater weight" in the differentiation process than any Measures of School Quality or Student Success



What has (and hasn't) Changed With HQT?

 The <u>TERM</u> "Highly Qualified Teacher" has been deleted from ESSA

• **BUT** the underlying requirement remains mostly unchanged.



# **Highly Qualified Teacher Change**

- Updated ESSA Language:
- "A teacher who meets the applicable State certification and licensure requirements, including any requirements for certification obtained through alternative routes to certification, or, with regard to special education teachers, the qualifications described in section 612(a) (14) (C) of the Individuals with Disabilities Education Act".

• Paraprofessionals requirements under Title I remain unchanged.



### **Kansas State Consolidated Plan Timeline (draft)**

November 1: Components are assigned to KSDE Staff

November 8: ESEA Advisory Council virtual meeting update

November 15 - February 1: Writing 1st draft of State Consolidated Plan

(KSDE Staff in partnership with internal and external stakeholders)

February 1: Various components of plan are due

March 1 - April 20: Garner feedback from advisory councils

April 20: Revisions are submitted and 2<sup>nd</sup> draft is completed

May 1: Post, for 30 day required comment period, to the KSDE website

June 1: Make revisions based on comment period feedback

June 30: Final draft completed

July 1: Submit Kansas State Consolidated Plan to the DoE

September 18: USDoE has 120 days to conduct a peer review

Following Peer Review: Kansas has 45 days to amend

Plan must be reviewed and revised every 4 years



### **Components of State Consolidated Plan**

Begins with a DRAFT worksheet divided into 5 components:

- Consultation and Coordination
- Academic Assessments
- Accountability, Support, and Improvement for Schools
- Supporting Excellent Educators
- Supporting All Students


