ESEA Exit Criteria for CSI, TSI, and ATS

CSI Title, TSI, and ATS buildings

- In order to exit, a building must have been involved a minimum of two consecutive years working with the Kansas Learning Network (KLN). The school leadership team, including the principal, must participate in all required supports provided by KLN including; a comprehensive needs assessment, root cause analysis, and development of a plan to address those findings utilizing evidence-based practices. The building plan must be maintained on the KansaStar platform.
- The building must meet the 95% participation rate for state assessments.
- The building must show growth in closing achievement gaps and ongoing improvement on state assessments for English language arts and math, progress towards proficiency on the KELPA for English Learners, and improved graduation rates.
- The building should work with KLN to provide supporting documentation to the KSDE for review.

**It is possible for a building to meet the exit requirements and be re-identified as a CSI, TSI, or ATS school during the next identification period.

CSI High School Graduation

- In order to exit, a building must have been involved a minimum of two consecutive years working with the Kansas Learning Network (KLN). The school leadership team, including the principal, must participate in all required supports provided by KLN including; a comprehensive needs assessment, root cause analysis, and development of a plan to address those findings utilizing evidence-based practices. The building plan must be maintained on the KansaStar platform.
- The building must meet the 95% participation rate for state assessments.
