| June 5                                   | <ul style="list-style-type: none"> <li>• Notice of Initial Data Collection (SSIDs available in KIAS)</li> <li>• Begin process of locating documentation for selected students</li> </ul>  |
| Data Collection<br>July 1 - Sept. 15     | <ul style="list-style-type: none"> <li>• Districts enter yes/no for all 23 questions for each SSID that was pulled</li> </ul>   |
| Data Verification<br>Sept 20 - Oct 2     | <ul style="list-style-type: none"> <li>• Random districts are notified (20 districts that self-reported compliance)</li> <li>• Random districts upload documentation for select questions</li> <li>• Districts that reported non-compliance can upload documentation they have located to support compliance</li> </ul> |
| Compliance Verification<br>Oct 11-Oct 25 | <ul style="list-style-type: none"> <li>• Districts notified of potential non-compliance may upload additional documentation to verify compliance</li> </ul>   |
| Status Letters<br>Oct. 31                | <ul style="list-style-type: none"> <li>• Districts are notified of compliant or non-compliance</li> </ul>   |
| DCAP Window<br>Nov. 1- Dec. 2            | <ul style="list-style-type: none"> <li>• Districts reported as non-compliant complete one district corrective action plan for each non-compliant question</li> </ul>  |
| ICAP Window<br>Nov. 1 – April 1          | <ul style="list-style-type: none"> <li>• Districts reported as non-compliant complete one individual corrective action plan for each non-compliant question</li> </ul>  |
| Updated Data<br>May 15 – May 29          | <ul style="list-style-type: none"> <li>• Districts answer yes/no for each non-compliant question for select files (IEPs dated 3/14/25-5/14/25)</li> </ul>   |
