Preschool-Aged At-Risk and Kansas Preschool Pilot

Exciting Changes for Preschool-Aged At-Risk

- In districts operating approved programs, four-year-old students who meet the existing at-risk criteria for preschool-aged at-risk students and who are enrolled and attending on September 20 will automatically count as 0.5FTE for the 2020-2021 school year.



Preschool Programs Evidence Based Practices Survey Results
