Name/Educator ID: This is the name the individual submitted to KSDE and their official KSDE ID number. Regardless of what endorsements they get or the status of their license, this ID number will be their unique identifier with KSDE.

Expired License History: This applicant has never held licensure from KSDE.

Application Status: Application in process includes any change to existing licensure as well as new license applications.

Status Date: Shows the last time the record was touched by Teacher Licensure. It is likely the 11/2/20 date reflects the date that a request for information was sent to the applicant. Applications may be purged after 90 days of inactivity, so this applicant needs to respond as soon as possible.

Application Status

There are two types of substitute licenses in Kansas, SUB and ESUB. The time a SUB (Substitute) or ESUB (Emergency Substitute) is allowed to substitute is on their license. The substitute regulations may be found at K.A.R. 91-31-34(b). Licensed teachers may substitute in any area or grade they are not licensed in for up to 125 days per school year.

Above is the license for an Emergency Substitute. At the bottom of the license is a section for Education with the words "No Education data found". Had this person submitted evidence of a college degree (Bachelors or higher) to KSDE, the college, year of degree, and degree would be listed in this section and the license would state "You may substitute up to 60 school days each semester in one school district. You cannot substitute for more than 15 days in the same assignment."

Note that this license has a "Print License" button in the top section. This allows a formatted certificate to be printed. This button is only available when a license has been approved and is active.

Using the information visible, we can form a fairly accurate timeline of this teacher's licensure history. Look towards the bottom of the information to "Expired License History".

This teacher has had an esub in the past and had a provisional license in Gifted before getting the full endorsement. Their Initial license was from 2019-2021 and the High Incidence and Elementary endorsements date from that license.

What can this teacher do?

This teacher has Elementary K-6 and the special education endorsement High-Incidence 6-12. The special education endorsement is not a content endorsement and does not enable the teacher to be the sole teacher of a classroom.

This teacher is able to teach general education students in grades Kindergarten through grade 6, but not grades 7-12 or early childhood. They are able provide gifted services to students K-12. In grades 6-12, this teacher could co-teach with another teacher correctly licensed for content, or consult on IEP services, or provide IEP services directly to students identified with "high incidence" disabilities, but could not be the sole teacher of a classroom due to the lack of a content endorsement for those grades.

As a substitute, this teacher could teach any grades.
