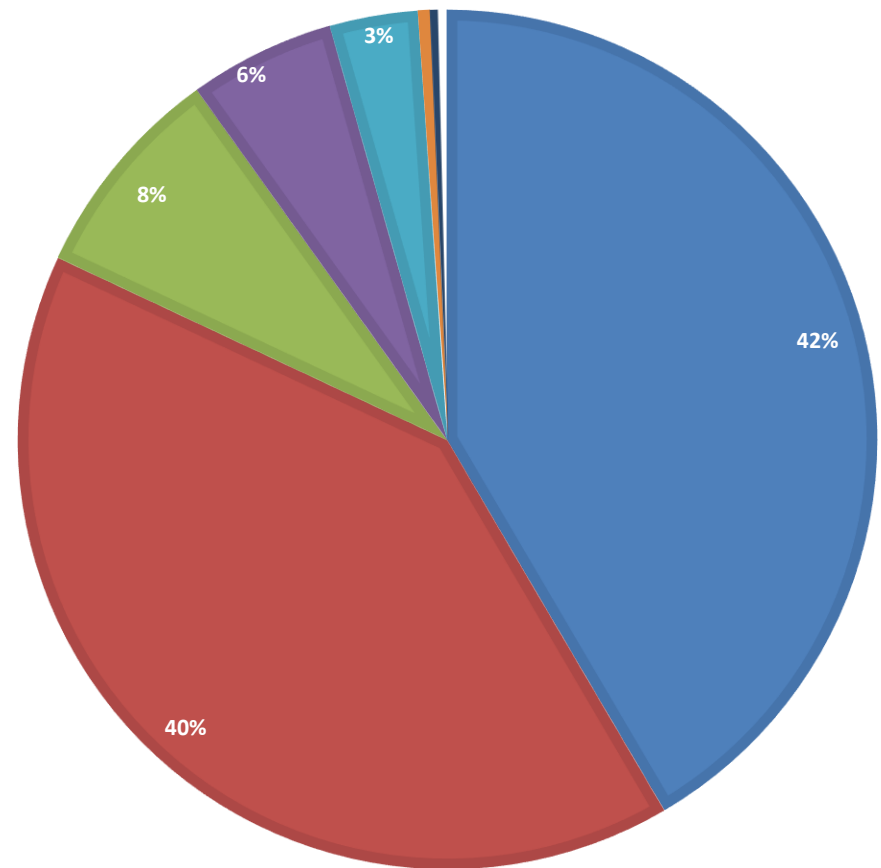
Eligible Students Verified for the Tax Credit for Low Income Students Scholarship Program

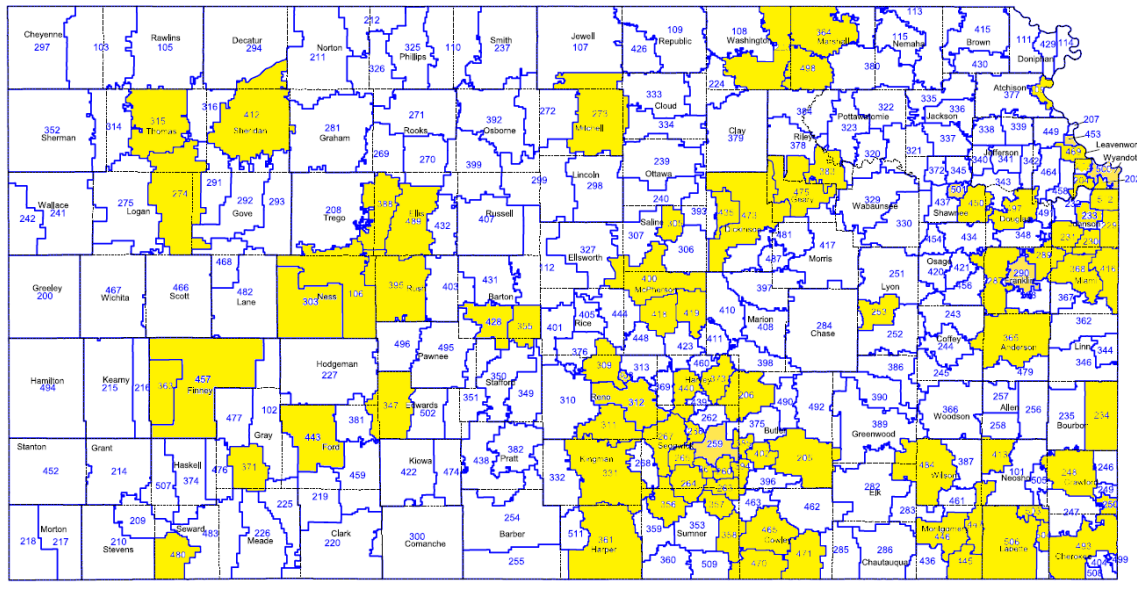

Districts with eligible students for the Tax Credit for Low Income Students Scholarship Program shown below in yellow



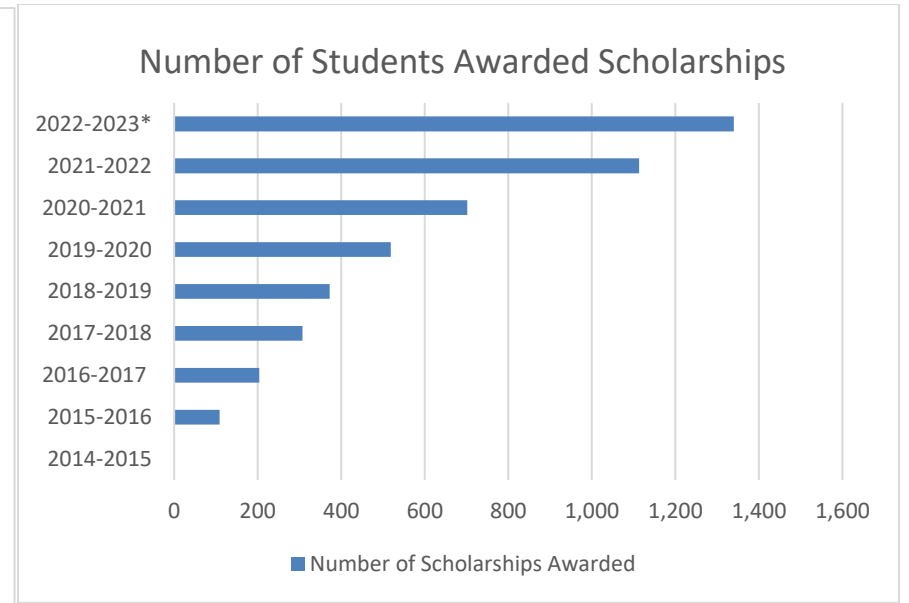
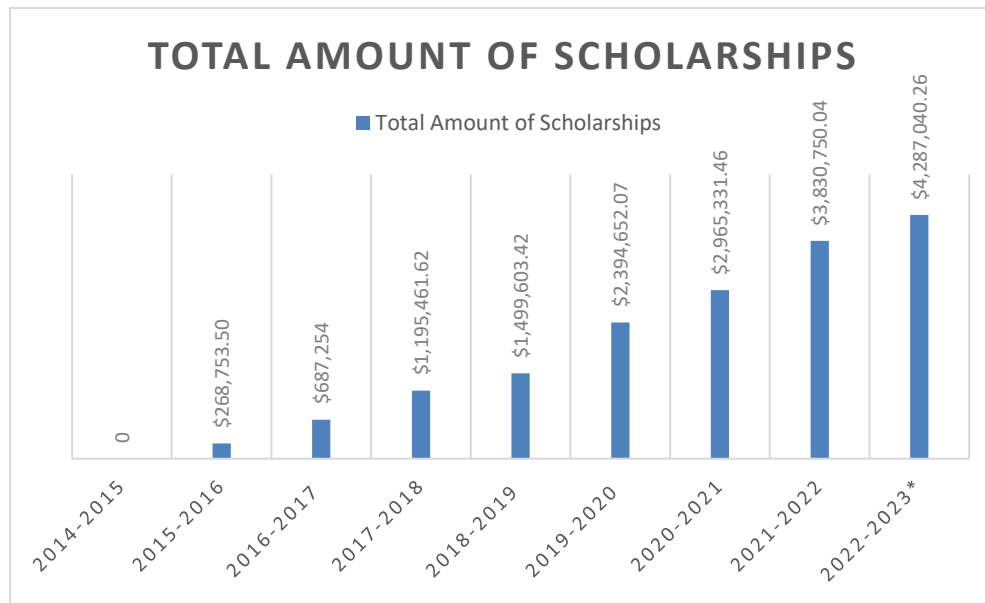
Scholarships Awarded

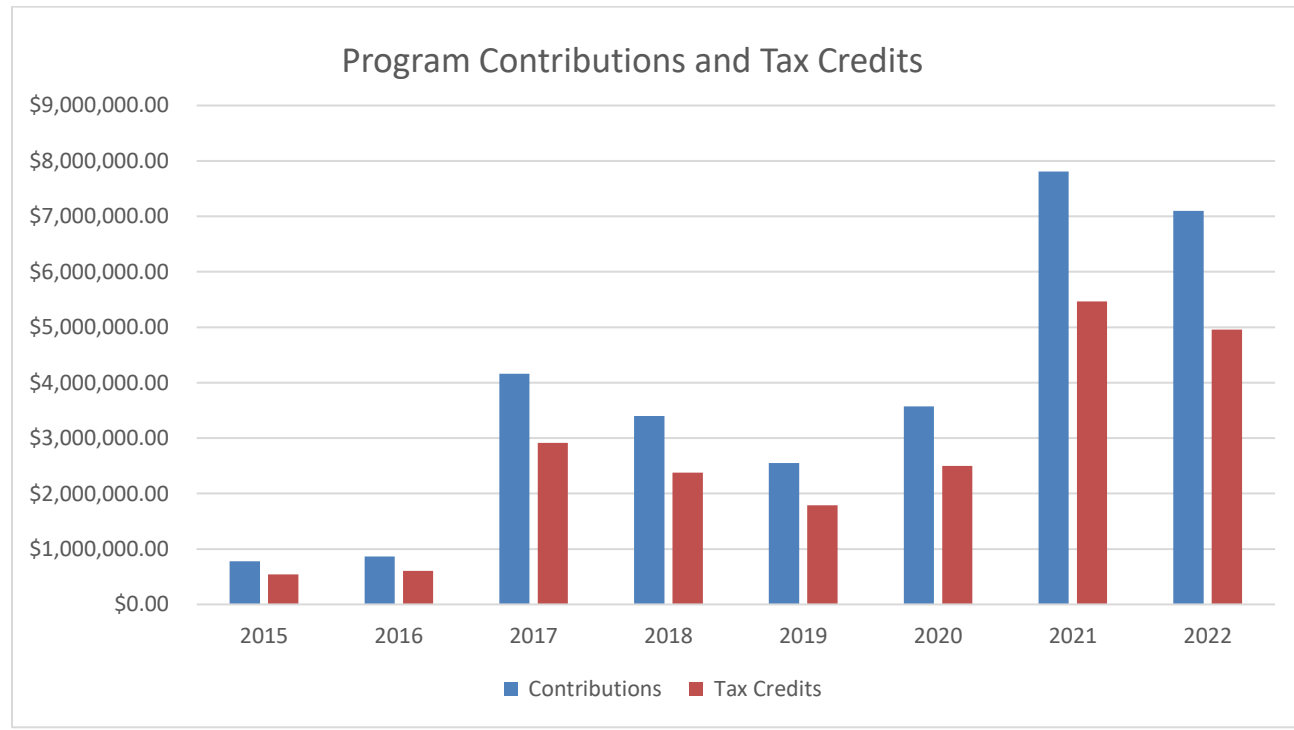
Contributions and Tax Credits

On and after July 1, 2020, a qualified private school shall be accredited by the state board or a national or regional accrediting agency that is recognized by the state board for the purpose of satisfying the teaching performance assessment for professional licensure.
