Subject: Impact Aid – Local Tax Proportion and Disparity
(FY2019 actuals used for FY2021 estimates)

The purpose of this memorandum is to give you notice, that pursuant to section 7009 of the Elementary and Secondary Education Act, or 20 U.S.C. §7709, the State of Kansas is requesting permission from the federal government to take federal impact aid payments into account in determining state aid payments to school districts during the state fiscal year 2021. Final data must be submitted to demonstrate that the State's program met the disparity standard for fiscal year 2021.

Below is a column explanation of the local tax proportion displaying the portion of local tax revenues covered under the state equalization program, as required by 34 CFR 222.163(b).

- Column 1 - 2018-2019 Actual General Fund local tax revenues
(Beginning FY15, 20mills ad valorem sent to State Treasurer and redistributed as State Foundation Aid)
- Column 2 - 2018-2019 Actual Local Option Budget (LOB) local tax revenues
(USD Budget Code 08 – Budget Lines 15, 20 and 25)
- Column 3 - 2018-2019 Actual Total Tax Revenues (Column 1 plus Column 2)
- Column 4 - 2018-2019 Actual Local Tax Revenues Not Covered Under the State Equalization Program
(USD Budget Code 10 - Adult Education, Budget Lines 15, 20 and 25)
- Column 5 - 2018-2019 Actual Total Tax Revenues (Column 3 plus Column 4)
- Column 6 - Tax Proportion of Local Revenues Covered Under the Equalization Program (Column 3 divided by Column 5)
- Column 7 - Deductible Federal Impact Aid Receipts Per 34 CFR 222.61 – Actual amounts of Impact Aid funds deducted by the Kansas Department of Education during the 2018-2019 school year when determining state aid to LEAs.

Computation of Disparity: The computation of disparity is performed as required by 34 CFR 222.63(a) on an expenditure basis. The computations are displayed on the pages to follow.

1. The Per Pupil amounts are ranked in descending order.
2. The 95th and 5th percentiles are identified as follows:
 - a. The total weighted full-time equivalency (FTE) is multiplied by 5% to obtain the target number needed to find the 95th and 5th percentiles of the total weighted enrollment.
 - b. The total weighted FTE are added from the top down until the target number is reached but not exceeded; the next value down identifies the LEA at the 95th percentile.
 - c. The total weighted FTE are added from the bottom up until the target number is reached but not exceeded; the next value up identifies the LEA at the 5th percentile.
3. The amount per pupil at the 5th percentile is subtracted from the amount per pupil at the 95th percentile. The result is divided by the amount shown for the LEA at the 5th percentile, yielding the percentage of disparity.

Below is a column explanation for the computation of Disparity as required under Section 7009(b)(2).

Column 1- This is the actual full-time equivalency (FTE) weighted enrollment for the 2018-19 school year. Kansas uses September 20th as the count date for determining the general fund budget for school districts (or the date following if the 20th falls on a weekend). Districts may qualify for a 2nd count (February 20) if they have military dependent students not enrolled on September 20, of at least 25 FTE or 1% of their September 20 enrollment. The weighted FTE is composed of:

- adjusted enrollment FTE is the higher of the first preceding school year (2017-18) or second preceding school year (2016-2017) plus current year (2018-2019) 4-year old at-risk. If a district meets specific criteria, they may be eligible to use the three-year average (2015-2016, 2016-2017 and 2017-2018) plus current year 4-year old at-risk.
- low or high enrollment weighted FTE
- bilingual weighted FTE (the higher of bilingual contact hours times .395 or bilingual headcount times .185)
- vocational weighted FTE (vocational FTE times .50)
- at-risk weighted FTE (the number of eligible students that qualify for free lunches times .484)
- high density at-risk weighted FTE (the higher of high density at-risk calculated at the district level or sum of building level)
- new facilities weighted FTE (enrollment of students attending a new facility times .25)

- transportation weighted FTE (based on eligible students \geq 2.5 miles from residence to attendance center: the higher of 2016-2017 or 2018-2019 transportation aid divided by \$4,165)
- ancillary facilities weighting (USD 229, USD 230, USD 231, and USD 233 Board of Tax Appeals amount divided by \$4,165).
- cost of living weighted FTE (USD 229, USD 231, USD 232, USD 233, USD 416, USD 497 and USD 512 Board of Tax Appeals amount divided by \$4,165)
- Ft. Hays State University – Math & Science Academy FTE
- virtual enrollment FTE
- special education weighted FTE

Column 2 - 2018-2019 Actual General Fund Expenditures; includes Special Ed state aid, Virtual Education state aid and Extraordinary Need State aid (Code 06 Line 175)

Column 3 - 2018-2019 Actual Supplemental General Fund Expenditures (Code 08 Line 175)

Column 4 - 2018-2019 Actual General Fund and Supplemental General Fund Expenditures (Column 2 plus Column 3)

Column 5 - The expenditures per pupil were computed by taking Column 4 divided by Column 1. This column was listed low to high. We disregarded expenditures above the 95th percentile and below the 5th percentile. The expenditures per pupil (weighted FTE) at the 5th percentile is \$5,456.67 (Circle School District #375) and the expenditures per pupil (weighted FTE) at the 95th percentile is \$5,729.32 (Olathe School District #233). The resulting disparity is 5.00% and is within the 25 percent disparity allowed under section 7009(b)(2).
