Facts on using web applications to submit KSDE data and reports

- Web applications are reports submitted to KSDE through an authenticated submission website: <https://apps.ksde.org/authentication/login.aspx>
- When web applications are available for data entry, KSDE will send a listserv message which will provide instructions how to submit your data to KSDE online and when it is needed.
- An individual login and password is needed to access each report. New staff members are required to register and be approved by the superintendent before gaining access to enter or review data.
- For assistance registering or logging into this site, contact the KSDE Help Desk at (785) 296-7935. Open and close dates are subject to change.

Food Service Claims

Food service claims can be submitted to KSDE at any time -- but no later than 60 calendar days after the claim month. Claims will be paid according to when they are received. **Questions?** Call Jennifer Barger at (785) 296-4965 or Nicole Norwood at (785) 296-2020.

* **Accreditation Licensure Waiver (Form 16) Certification of Staff:** Applications should be received in the TLA office by **November 1**.

Attn: Teacher Licensure and Accreditation (TLA), Room 106, Kansas State Department of Education



If a district hires or reassigns a person requiring a waiver after the start of the school year, and the individual cannot meet the current enrollment requirement until second semester, the completed waiver request must be submitted by **February 1** of the current academic year.
