Pittsburg State University has created a state approved, innovative, special education program that allows experienced paraprofessionals, who hold a bachelors degree, to earn an initial special education license in Kansas. While it is an initial license it is a Masters level program, however, candidates are not considered the Teacher of Record in their classrooms, so it is not considered an alternative route licensure program.
